Here presentations will be given and discussed, in order to prepare the next phase leading to the first Milestone Conference to be held in <u>Madrid</u>, and organized by Amelia Sanz and her *equipa*.

In the *Symposium on Early Modern Women*, organized by Eleanor Lowe and hosted at Oxford Brookes University, Oxford on 19 June 2010, Suzan van Dijk will present "Georgette de Montenay, Anna Roemers Visscher and Other Women Translating/Commenting Upon Each Other".

Continuing the tradition created within the NEWW network, Kerstin Wiedemann and Elise Müller-Adams organize an international conference next spring. It is entitled: Routes out of marginalization: Gender and narrative practice in novels by German-speaking women, 1780-1914, and will be held not in May, but on 24-25 June 2010, at the University of Nancy (France).

The Conference is organized by the *Centre d'études germaniques interculturelles de Lorraine* (CEGIL), University of Nancy 2, and the *Centrum für Postcolonial und Gender Studies* (Cepog), University of Trier. Focusing on the <u>German female novel</u>, this conference aims to continue the research presented in May 2009 in the third annual NEWW conference in Bochum, entitled *Theorizing Narrative Genre and Gender* (see also NEWWsletter 3.3).

Members' activities

NEWW members Ileana Mihaila, Gillian Dow, Suzan van Dijk took part in a conference about Madame de Maintenon, organized by Marie-Emmanuelle Plagnol and Christine Mongenot in Paris and Versailles (10 and 11 March). They spoke about Maintenon's reception in Romania, England and the Netherlands.

On 8th to 10th April 2010, the annual meeting of the Renaissance Society of America was held in Venice, gathering over 2000 participants, among them COST Action members Nieves Baranda, Mónica Bolufer and Marie-Louise Coolahan, and also Lisa Vollendorf, member of the COST Action Advisory Board. Several sessions were devoted to early modern women's lives and writings, and many other included contributions on women writers, such as Moderata Fonte, Lucrezia Marinella, Arcangela Tarabotti, Christine de Pizan, Oliva Sabuco, Valentina Pinelo, Katherine Philips, Anna Maria van Schurman, to mention only a few. Some of the sessions were organised by academic societies such as GEMELA (Grupo para el estudio de la Mujer en España y las Américas – Pre 1800) and the Society for the Study of Early Modern Women, and others by relevant specialists Anne J. Cruz, Martine van Elk, Anne Jacobson Schutte, among others. Papers concerned for instance: female authorship and authority, epistolary writing, relations between mothers and daughters and many other aspects of women's experience and intellectual and artistic practice, and of gendered cultural practices in the Renaissance.

Call for papers

2010, 3 September, Early Modern Women in Continental Europe, Interdisciplinary colloquium held at Trinity College Dublin, in celebration of the launch of the Forum for the Study of Early Modern Women in Continental Europe. This Forum is designed to cross both disciplinary and geographical boundaries.

Early career researchers are particularly encouraged to submit proposals – to be sent to organizer Eavan O'Brien (obriene@tcd.ie), by Friday 7 May 2010.

2010, 11-12 December, *History in travel narrative 1589-1826*, Paris, Sorbonne Nouvelle, Joint conference organised by PRISMES (CREA XVIII, Epistémè), Sorbonne nouvelle, and CIERL, Québec.

This conference will examine the representation of history in travel narrative. A European's perception of countries and peoples with no "history" is not the same as that of

"civilized" nations. What model of historical change do travel narratives project? History as a decline from some mythical or mythicised origin, cyclical history, history as the unfolding of a providential design, as progress? The evolution of those categories over the period considered will be investigated; this period stretches from 1589, which saw the publication of Richard Hakluyt's Principal Navigations, to 1826, when William Ellis's *Narrative of a Tour through Hawaii* came out.

What is the influence of historiography at any given time on the representation of history as experience in travel literature? How does travel narrative validate its status as historiography?

From a more anthropological viewpoint, does the discovery of new or different spaces or places shape the perception and construction of time? Is there any interaction between the conception and depiction of space and those of time, especially of the time needed for the evolution of manners, customs and institutions which differ from those familiar to the traveler? Does this entail a relativisation of time? How does a European (or Europeanised) nation's past constrain the analysis of the fabric and customs of the areas visited? Is the historicisation of lived experience limited? What is the impact of measuring instruments on this experience and the account thereof?

Those are some of the questions which will be addressed in this conference. Please send proposals – 200-250 words – <u>before 15 June</u> 2010 to organizers:
