NEWW project news

On May 22-23, the second of our international NEWW conferences, entitled Readers, Writers, Salonnières. Female Networks in Europe 1700-1900, was held in Chawton. In the beautiful rooms of Chawton House (see above), we discussed women ranging from Elisabeth Rose of Kilravock to Helene Druskowitz, Amely Bölte, Sophie Duvaucel, Henriette Herz and Catherine de St. Pierre – not all of them familiar names, but all of them women who did participate in the creation of female networks. Interestingly, the continuity of NEWW research was also apparent: some women who had been discussed last year during the Geneva conference - Madame de Staël, Mary Wollstonecraft and Elisabetta Caminer Turra, for example - were again the subject of papers in Chawton. The executive committee (Suzan van Dijk, Anke Gilleir and Alicia C. Montoya) met again in June in Utrecht, where they discussed ongoing NEWW matters (funding possibilities, network organization) and prepared upcoming NEWW events, including the second in our series of "November meetings" (November 28, Utrecht), and the NEWW conferences in May 2008 (Chawton) and May 2009 (Bochum).

NEWW call for papers

CALL FOR PAPERS. Theorizing Narrative Genres and Gender. Proposals are invited for the third international NEWW conference, to be held at the Ruhr-Universität Bochum (Germany), on 15 and 16 May 2009. This conference would like to discuss (1) the ways in which certain narrative genres (novels, short stories, fairy tales, autobiographies, personal diaries, etc.) have been gendered, and (2) the impact that these texts have had on readers, both men and women. Finally (3), what consequences have readers' reactions and the gendered critical discourse had for the formation and development of narrative literary genres?

Recent research, for example on the feminocentrism of the seventeenth- and eighteenth-century French and English novel, on narratology or on the differences between female and male reading, has shown that not only is the literary discourse tied to issues of gender, but the

metadiscourse is equally imbued with it; the 'querelles des femmes' were frequently intertwined with literary disputes.

In keeping with NEWW's objectives, the conference will cover a relatively long time period, extending from 1400 to 1900, and will also present contributions treating European literatures that are considered 'marginal'.

Contributors could address the following issues:

- the effects that literary genres (*e.g.*, the novel) were supposed to have on a female public;
- the relationships between morality and literature, between realism and idealism;
- the impact of the concept of gender on key aesthetic notions;
- the consequences for literary history;
- the mechanisms of inclusion and exclusion in literary movements;
- the 'gendered' quality of literary theory and narratology.

Contributions will preferably move beyond individual cases and attempt to expand the discussion within a theoretical perspective. Proposals (approximately 250 words) in French or English, the conference languages, may be sent to the organisers Suzan van Dijk, Universiteit Utrecht (Suzan.vanDijk@let.uu.nl) and Lieselotte Steinbrügge, Ruhr-Universität Bochum (lieselotte.steinbruegge@rub.de). Contributions should be 20 minutes long. The articles resulting from this meeting will be published; a committee of readers will make a selection. Deadline for proposals: November 1, 2008.

Member profiles

<u>Faith E. Beasley</u> is Professor of French at Dartmouth College, Hanover, New Hampshire, USA. She specializes in women's writing and women's history of the French Ancien Régime. Her publications include Salons, History, and the Creation of Seventeenth-Century France (Ashgate 2006), Revising Memory: Women's Fiction and Memoirs in Seventeenth-Century France (Rutgers 1990), Approaches to Teaching

The Princess de Clèves (co-edited with Katharine Ann Jensen, MLA 1998). She is editing **Options** for **Teaching** Seventeenth and Eighteenth-Century French Women Writers (forthcoming MLA) book-length study of completing a relationship between France and India at the end of the 17th-century. She has also published numerous articles on French salon culture, women's memoirs, and on the intersections of history and literature during the early modern period.

Biljana Dojčinović Nešić teaches at the Department of Comparative Literature and Theory of Literature, Faculty of Philology, Belgrade University in Serbia. She was one of the founders of Women's Studies Center in Belgrade, as well as Indoc center in Association for Women's Initative. She has been editor-inchief of Genero, a journal in feminist theory, since 2002. Her MA thesis, published as a book, Ginokritika: Rod i proučavanje književnosti koju su pisale žene (Gynocriticism: Gender and the Women's Writing) in 1993, was a pioneering work, introducing the category of gender to literary studies in Serbia. She has also published Odabrana bibliografija radova iz feminističke teorije/ženskih studija 1974-1996 (Selected Bibliography in Feminist Theory and Women's Studies 1974-1996). Her most recent books are sobe, portreti Gradovi, (Cities, Portraits), a collection of essays on H. James, V. Woolf, C. Gilman, M. Atwood, J. Updike and K. Chopin, GendeRings: Gendered Readings in Serbian Women's Writing (CD Rom, in English) and Kartograf modernog sveta (Cartographer of the Modern World), a study on the novels of John Updike.

Lieselotte Steinbrügge is full professor of Romance Philology at the Ruhr-Universität Bochum (Germany) since 2004, where she is also a member of the directory board of the master course in gender-studies. Before, she held visiting positions at Dickinson College (USA) and Martin-Luther-Universität Halle-Wittenberg (Germany). Her research in the field of gender-studies include eighteenth century discourses on gender, especially the anthropological discourse

in the French Enlightenment; epistolarity; the relation of narrative genres and gender in seventeenth and eighteenth century France. She is organizing together with Suzan van Dijk the next NEWW conference (15 and 16 May 2009) on Theorizing Narrative Genres and Gender / Théorisation des genres narratifs et Études de genre. Embodying Women's Culture: The Hispanic Atlantic, 1500-1800. Officially founded in 1999 and an Allied Organization of the Modern Languages Association, GEMELA (formerly AEEA) strives to unite scholars across traditional disciplinary boundaries through its focus on women's cultural production in medieval and early modern Spain and colonial Latin America, pre-1800. Our purpose is to distribute information and knowledge about women and their role as cultural producers. Our conferences publications encourage teaching research based on all approaches related to our principal field of inquiry. The focus of this issue springs from the theme of GEMELA's fall 2008 conference, and reflects increasing scholarly attention to transatlantic studies and continuing interest in feminist body studies. The body, the senses, and material culture mediated women's place in Hispanic social contexts, but they also attention to women's agency: selffashioning, speech, writing, listening, and visual perception. We expect to use the Atlantic as a complex space of analysis; proposals are encouraged to move beyond the national as a critical category and to explore women's writings and cultural productions from an intercultural, comparative perspective. Emphasis could include the points of intersection between cultures and such processes Atlantic creolisation, hybridity, and translation. Suggested topics, all of which refer to women's writings and cultural productions in the early modern and colonial period, include (but are not limited to):

- Dress and Self-Presentation
- Visual Culture
- Aurality and Orality

- Language, Codes, and Silences
- Spaces and Movement
- Textual Authority
- Mediated Voices
- Sexuality and the Erotic Imagination

Essays in English and Spanish will be accepted. Articles should be approximately 17-22 pages in length (no more than 8,500 words), double spaced, Times New Roman 12-1", in MLA style with endnotes, and in Word format. Please attach a separate cover sheet with the title, author's name, affiliation, and e-mail address; no identification should be included in the body of the article itself, as the reviews will be anonymous.
